5. Winners will be notified by announcement by the Emcee from the stage, announcement on the LED screens, followed by email and/or telephone with further instructions on how to claim his/her prize. If the selected entrant cannot be located or does not respond within 10 days of notification, the entrant forfeits the prize and the prize will be awarded to an alternate entrant.
